Subject: 'Har Ghar Tiranga' programme during Independence week(11-17Aug 22)-reg.

Reference: HQrs. Office F. No. Estt. Coord /3012/Circular/Vol. IX dated 14.07.2022.

Please refer to Hqrs circular cited under reference. 'Azadi Ka Amrit Mahotsav' (AKAM) is being celebrated to commemorate the 75 glorious years of a progressive Independent India. National Implementation Committee (NIC) headed by Hon'ble Minister of Home and Co-operation has approved the programme of '**Har Ghar Tiranga**' under the aegis of AKAM. As part of this initiative, following tasks have been suggested for MoD:

(i) **Hoisting of flags:** All the officers and staff are requested to hoist the National Flag of India in their homes during Independence week (11-17 Aug 22). The display/hoisting/use of the Indian National Flag is governed by the Flag Code of India, 2002 and the prevention of Insults to National Honour Act, 1971.

(a) The Flag Code of India, 2002 was amended vide Order dated 30th December, 2021 and paragraph 1.2 of Part-I of the Flag Code of India, 2002 shall be read as under:

1.2. "The National Flag shall be made of hand spun and hand woven or machine made, cotton/polyester/wool/silk khadi bunting."

(b) The Flag Code of India, 2002 has been further amended vide Order dated 20th July, 2022 and clause (xi) of paragraph 2.2 of Part-II of the Flag Code of India, 2002 shall be read as under:

(xi) "where the Flag is displayed in open or displayed on the house of a member or public, it may be flown day and night;"

(c) A member of a public, a private organization, or an educational institution may hoist / display the National Flag on all days or occasions in accordance with the dignity and honour of the National Flag.

- (d) National Flag shall be rectangular in shape. The flag can be of any size, but the ratio of the length to the height (width) shall be 3:2.
- (e) Whenever the National Flag is displayed, it should occupy the position of honour and should be distinctly placed.
- (f) A damaged or disheveled Flag shall not be displayed.
- (g) The flag should not be flown from a single masthead simultaneously with any other flag or flags.
- (h) The Flag should not be flown on any vehicle except of the dignitaries mentioned in Section IX of Part III of the Flag Code, such as President, Vice President, Prime-Minister, Governors etc.
- (i) No other flag or bunting should be placed higher than or above or side by side with the National Flag.
- (ii) **100% participation of Armed Forces & Ex-Servicemen:** All the Ex-servicemen working in this organisation are requested to participate in the 'Har Ghar Tiranga' programme and make it a grand success.
- (iii) **Virtual pinning of the Flag:** All the Officers and Staff are requested to pin a virtual Flag by following the link <https://harghartiranga.com>
