4. Further, all Pr. IFA/IFA Officers will be considered as part of the Proforma controllers to whom they are attached and they will therefore take part in the internal matches conducted by the respective PCsDA/CsDA organizations for selection of players.

The Secretary, DARC, Main Office has been directed by the Competent Authority to hold internal matches amongst the Officers/Staff (Men & Women) under this organization in consultation with the DARC Secretaries of both the PAOs and the ACDA I/c, O/o AAO (Army), Vizag by **07.10.2022** and to intimate the names of the players selected (three men and two women) by the same date.


