Sub: DPC for promotion of AAOs to the grade of Accounts Officer.

Hqrs Office vide Lr. No. AN/II/2151/DPC/AAO to AO/2023, dt. 19.01.2023 has intimated that a proposal to convene a DPC for promotion of eligible Assistant Accounts Officer to the grade of Accounts Officer against the vacancy year 2023 is under consideration.

The AAOs serving in this organisation as mentioned in the **Annexure-A** to this letter are falling within the zone/extended zone of consideration. The following information along with supporting documents in respect of the concerned AAOs has been called for by the Hqrs Office.

- Whether any of the dependent is differently able, if so, mention details thereof with supporting documents/certificate.
- Whether spouse is working. If so, mention details viz. Central Govt/State Govt/PSUs/Others
- In case of SC/ST category AAO an undertaking (**copy enclosed**) from the AAO concerned as per the guidelines contained in DoP&T OM dt 09.09.2005.
- Request for a particular choice station, if any, from the AAO with relevant information regarding family problems, medical reasons etc. (**duly supported with documents**) that the officer may like to mention in support of his/her request for posting to a particular station on promotion to AO's Grade for consideration of the Competent Authority (**copy enclosed**)

In connection with (iv) above, it has been directed to bring to their notice that it should not be viewed as a promise to post them at their choice stations. The posting will be decided duly considering the information supplied by them and, therefore, no further representation for change of posting will normally be entertained once the promotion orders are issued by the HQrs, unless the request is for forgoing the promotion. No further representation for change of posting on promotion should, therefore, be forwarded unless it is for forgoing promotion or warranted by some unforeseen later developments. Further, since the circumstances of the eligible AAOs who have given choice stations earlier, might have changed, fresh applications are required to be submitted in respect of each eligible AAO falling in the zone of consideration so that while deciding their postings, the latest grievances/problems mentioned by them be kept in view for considering their posting on promotion to AO's grade.

It is requested to accord **"TOP PRIORITY"** and forward the above by **27.01.2023** positively.
