Subject: Mega Rally/Dharna/Protest on 08.07.2023 at Jantar Mantar against New Pension Scheme (demanding Old Pension Scheme) - Regarding.

It has been communicated by the HQrs. Office that Ministry of Defence, Department of Defence vide D(JCM) ID No. 17(2)/2020–D(JCM) dated 06.07.2023 has intimated that National Movement for Old Pension Scheme (NMOPS) has decided to make rally/protest at Jantar Mantar on **08**th **July**, **2023**.

2. In this context, it is brought to the notice of all the officers and staff of this organization that as per the provisions of **Rule 7 of CCS (Conduct) Rules 1964**, no Govt. Servant shall resort to or in any way abet any form of Strike or coercion or physical duress in connection with any matter pertaining to his service or the service of any other Govt. Servant, and any Govt. Servant violating the above provisions will be liable for disciplinary action in addition to invoking the provisions of **FR (1)** which stipulates that pay and allowances is not admissible to an employee for his absence from duty without any authority.

3. It is therefore, impressed upon all the officers and staff of this organization to desist from participation in the Strike in their own interest. Participation in any way in the above dharna/protest/strike will be viewed seriously. Disciplinary action including recourse to provisions of **FR 17 (1) & Rule 7 of CCS (Conduct) Rules 1964**, will be initiated against the participants. Further, it is impressed upon all the leave sanctioning authorities <u>NOT TO SANCTION</u> any kind of leave to the officers and staff serving under them if applied for, during the period of the proposed protest/strike. The contents of this circular may be brought to the notice of all the officers/staff working in your office/section and their dated signatures in token of having noted the same may be obtained and recorded at your end.
