

RULES FOR HIrd ALL INDIA DAD DEBATE CONTEST

SCHEME

The Debate Contest shall be held at 3 levels:

<u>Preliminary Round</u>: To select a team from each PCDA/CDA/CFA/IFA for zonal level contest.

Zonal Round: To select a team from each RTC for final round.

Final Round: To be organized during Training and Development Week in first week of

December, 2017

GENERAL RULES

- 1. The debate can be delivered either in Hindi or English.
- 2. The topics for the debate at the Preliminary, Zonal and the Final round are to be the same.
- Participants would not be allowed to refer to any pre-prepared notes/sheets.
- 4. Each contestant would be given a maximum time limit of 4+1 minutes, during which they have to wind up their narrative; after which they would be timed out and it would call for negative marking.
- 5. Time starts as soon as the participant occupies the lectern/dais.
- 6. A bell will be rung by the time-keeper at the end of 4 minutes , to indicate that only one minute is left, for he participant to wind up.
- 7. The participants would be judged on their clarity of content, proficiency in the given language, diction, analytical skills, time -precision and concept clarity, breath and nimbleness in dealing with the interjection questions.
- 8. Two interjections per contestant would be permitted to the audience at the end of each individual debate for each contestant.
- 9. The interjectors need to raise their hands, and the choice would be usually made by the compere/moderator based on the first visible basis.
- 10. The compere's decision regarding choice of interjector would be final.
- 11. Only one question would be allowed to one interjector.
- 12. No participant would be allowed to interject a fellow participant. •

- 13. In case of no interjections coming to an individual, two of the three judges are to put forward an interjection each to that participant.
- 14. The judges' decision will be final.
- 15. All the participants are to be briefed about the rules before the beginning of the contest. No queries will be entertained after the contest.

PRELIMINARY ROUNDS

- Principal Controllers/Controllers/PIFAs, IFAs to give wide publicity to the event by giving advance notice, especially to sub-offices.
- Principal Controllers/Controllers to nominate an appropriate panel of judges (2or 7 not less than that and the level should be JTS and above) for judging the contest.
- Every PCDA /CDA is to send only one team from their organization to respective Elecs.
- The team to be sent for the zonal round at concerned RTCs should comprise two
 individuals, one for the motion and one against it.
- PCsDA/CsDA may like to give some monetary/non-monetary token of appreciation to all participants/winning individuals at their discretion.

ZONAL ROUNDS

- RTCs will organize the zonal round for the winning teams of the preliminary rounds held at Controller offices coming under their jurisdiction.
- The team winning the zonal round at RTCs should be sent to the HQrs. Office for the
 final round. Last date for submission of the names of the winners in Zonal Round and
 the team from the Zone to the HQ office is 20th November, 2017. The details can be sent
