

Dear Shri Subbarayan,

Ministry of Environment, Forest and Climate Change (MoEFCC) is the nodal agency in the administrative structure of the Central Government for implementation of environmental, forestry and biodiversity conservation programs and policies. The Ministry's main activities include prevention and control of pollution, protection of the environment, conservation and survey of forests and wildlife, afforestation and regeneration of degraded areas, ensuring welfare of animals and research related to these activities.

2. In this context, the Ministry has been taking several measures to improve the environment of the country.
