Reference is invited to Para 4 (iii) (g) of Budget Division, Department of Economic Affairs, Ministry of Finance OM No. 15(39)-B(R)/2016 dt. 21/08/2017 circulated vide this office letter No. A/III/12157/CMP dt. 03/10/2017 regarding rush of expenditure in the closing month of Financial Year.

- 2. In the past, there has been huge rush of expenditure during last quarter of the financial year as well as during the last month of financial year and this has been adversely commented upon by C&AG of India. According to Rule 62(3) of General Financial Rules, 2017, rush of expenditure particularly in the closing months of financial year shall be regarded as a breach of financial propriety and shall be avoided. Further, Ministry of Finance has already sensitized all administrative heads that rush of expenditure in the year end be strictly avoided. Ministry of Finance's instructions seeking to restrict last quarter expenditure to 33% ceiling and last month (March) expenditure to 15% ceiling may be adhered to.
- 3. In view of the above it is requested that proper financial discipline as enumerated above may be ensured in the last quarter of the financial year 2018 -19.
