Sub: Observance of Vigilance Awareness Week – 2016

The Central Vigilance Commission – New Delhi vide their Circular No.10/09/16(I) Dated 19.09.2016 and No.10/09/16(II) Dated 23.09.2016 bearing No.016/VGL/030 dt:19.09.2016 & 23.09.2016 forwarded by HQrs office vide their letter No. AN/XIII/13006/2A/2016 dated 07.10.2016 has declared that this year, the Vigilance Awareness week would be observed from 31st October 2016 to 5th NOVEMBER 2016.

- The Vigilance Awareness week should commence with the pledge (copy enclosed) 2. on 31st October, 2016 at 11.00 am. This year the theme of observing Vigilance Awareness Week is "Public participation in promoting integrity and eradicating Corruption is a serious unethical practice that undermines trust and corruption". confidence in public officials and public confidence can only be gained by integrity in governance. In order to attain and sustain a corruption free society all stake holders should share the responsibility for creation of awareness of corruption as well as refrain from indulging in unethical acts. Aware, active, involved and empowered public is essential to any anti-corruption campaign. Anti-corruption strategies are not simply policies that can be planned in advance and isolation, but can only be developed in conjunction with public participation. Combating corruption is deeply rooted in human values and morals of individuals and the fight against corruption cannot be won without citizens' support, participation and active vigilance by all concerned. With this in view "Public participation in promoting Integrity and eradicating Corruption" has been chosen as the central theme for Vigilance Awareness Week, 2016".
- 3. Further as outreach activities for public/citizen, in line with the theme this year, to create greater awareness and participation of the public at large, the Central Vigilance Commission has envisaged a concept of "Integrity Pledge". As such two Integrity Pledges have been envisaged enlisting support and commitment of the citizens and the other for corporates/entities/firms etc., especially in the private sector to prevent and combat corruption. Both the "Integrity Pledges" would be available as an e-pledge on the Commission's website http://www.cvc.nic.in. The CDA Secunderabad has provided hyperlink to the Integrity Pledges on our website/intranet to enable wider participation of the stake holders. Copies of both the "Integrity Pledges" are enclosed.

- 4. In order to achieve the objective of the theme for public participation in spreading awareness of corruption, its ill-effects and in the fight against corruption, it is advised to consider organizing and conducting the following activities with zeal and enthusiasm during the Vigilance Awareness Period:-
 - Distribute pamplets, handouts on preventive vigilance/activities/whistle blower mechanism and other anti-corruption measures.
 - Workshops/sensitization programmes for employees and other stake holders on policies/procedures of the organization and preventive vigilance measures.
 - Bring out special issue of journals/newsletters on vigilance issues/systemic improvements and good practices adopted for wider dissemination and awareness.
 - Conduct various competitions such as debates, quiz etc. for the employees and their families on issues relating to anti-corruption.
 - Use organizational website for dissemination of employees/customer oriented information and avenues available for grievance redressal.
 - To disseminate and publicise the initiative to elicit wider participation of all stakeholders and also to encourage customers/public and corporates/entities/firms, etc., to take the Integrity Pledge as detailed in **Para 3** above.
- 5. A report about the activities in the week observed may be forwarded to this office by 10th November 2016 so as to furnish a consolidated report to the HQrs office.
