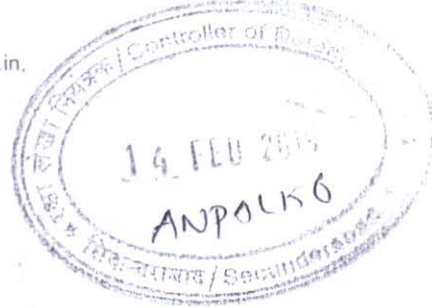

Implementation of Government decision on the recommendations of the 7th CPC-Revision of pension of pre-2016 Pensioners/Family Pensioners.

HQrs-letter No. AT/II/2701/pre-2016/Pen Rev/Report dated 15/01/2018.

Please refer HQrs. Office letter cited above, wherein it was requested to issue directions to the field audit offices for timely completion of cases of revision of pension of pre-2016 defence civilian pensioners/family pensioners.

2. Recently, one of the Head of the Organizations (HOO) has highlighted the need for early processing of cases by the field audit offices.

3. It is therefore, requested to issue fresh directions to the field audit offices under your jurisdiction to process the revision of pension cases received from unit authorities on priority basis and liaise with them for speedy submission of cases of revision of pension of pre-2016 Defence Civilian pensioners/ family pensioners so that the 100% completion target specified by the Ministry of Defence could be achieved by 31/03/2018. While issuing such instructions, the contents of HQrs. office letters no. AT/II/2701/pre-2016/Pen Rev/Report dated 15/01/2018, 29/11/2017, 21/11/2017 and 12/10/2017 and no. AT/II/2701/Orders dated 13/11/2017 and 10/11/2017 must be included.

4. As already intimated, the progress of completion of these cases is being monitored at various higher levels at the HQrs. Office as well as the Ministry of Defence. It is therefore, reiterated to ensure that the fortnightly reports in r/o civilians Non-DAD, civilians DAD and services (Annexure A, B & C) are received in this HQrs. Office by 11.00 AM on 1st and 16th of the month positively through email hqaudit.cgda@nic.in only.
