Subject: Fixation of pay on Bunching of pay stages in the revised pay structure under CCS (RP) Rules, 2016.

Reference: Your office letter No Paytech/4024/CGDA Corr dated 13-06-2019.

The case for grant of bunching benefit as referred vide your office letter cited above pertaining to PB 1 with grade pay Rs 1800/- has been examined in HQrs Office. In this regard it is stated that as per para 9 (ii) of the MoF, Department of Expenditure OM No 1-6/2016-IC/E-III A dated 07-02-2019 no further action is to be taken after benefit as a result of application of Rule 7 (1) (A) (i); the same has been elaborated in the illustration given under para 9 (ii) of MoF OM ibid.

2. However, it is observed from the case forwarded vide your office letter dated 13-06-2019 that benefit of bunching as a result of application of Rule 7 (1) (A) (i) has not been given, whereas para 9 (ii) of MoF OM dated 07-02-2019 rules out any further action only after benefit as a result of application of Rule 7 (1) (A) (i). MoF OM dated 07-02-2019 does not prohibit anywhere the grant of benefit of bunching for the middle stage of pay, if otherwise eligible.

3. In view, the rule position regarding the issue raised by your office is very clear, and the affected cases may be dealt with accordingly.
