Implementation of Govt. decision on the recommendations of the 7<sup>th</sup> CPC.

As per G.O.I. DP&W OM No. 38/37/2016-P&PW (A) dated 12.05.2017 the pension of the pre-2016 pensioners/family pensioners has to be revised according to the 7<sup>th</sup> Central Pay Commission on the basis of notional pay as on 01.01.2016 fixed by the H.O.D and Pay and Account Office (PAO) attached to that office from which the Govt. Servant had retired.

2. As per Para 17 of this office important Circular no. C-164 dated 30.05.2017(available on this office website [www.pcdapension.nic.in](http://www.pcdapension.nic.in)) pension will be revised by PCDA (P) Allahabad **only after receiving hard copy as well as soft copy(in CD) of the claim in proforma of LPC-Cum-Data-Sheet(as per prescribed in circular)** along with concerned all documents from HOO concerned after getting it vetted from PAO/LAO.

3. While preparing LPC-Cum-Data-Sheet for revision H.O.O shall mention a unique H.O.O. code which has to be obtained from this office as per procedure laid down in aforesaid circular.Utility may please be downloaded from website of this office for generation of LPC-Cum-Data-Sheet w.r.to Circular No.164 dated 30.05.2017

4. HOO may endeavour to mention Aadhar No.,PAN No.,Mobile No.,E-Mail ID of pensioner/family pensioner or spouse in the prescribed LPC-Cum-Data Sheet, if readily available. In case these details are not available, efforts may be made to obtain these details from the pensioner/familypensioner/spouse and subsequently propose amendments through use of the same LPC-Cum-Data-Sheet.

5. Pensioner's applications in regard to revision of pension w.e.f. 01.01.2016, is forwarded herewith for submission of the claim after completion in terms of Circular no. C-164 dated 30.05.2017, C-168 dated 10.07.2017 and C-169 dated 17.07.2017.
