

Subject: Fixation of pay of re-employed ex-servicemen.

Reference: Your office letter No Paytech/4002/Clarifications dated 05-06-2015.

The issue has been examined and it is stated that DOPT OM NO 3/19/2009-Estt (Pay II) dated 05-04-2010 prescribes the manner of fixation of pay in respect of the following categories of re-employed ex-servicemen:

- (i) Those personnel/officers who retired from service prior to 01-01-2006 and re-employed before 01-01-2006 (Para 3 (iv) of DOPT OM dated 05-04-2010),
- (ii) those personnel/officers who retired from service prior to 01-01-2006 and have been re-employed after 01-01-2006 (Para 3 (v) of DOPT OM dated 05-04-2010),
- (iii) those personnel who retired and re-employed after 01-01-2006 (revised Para 4 (d) (i) and 4 (b) (i) of DOPT OM dated 31-07-1986 as mentioned in para 2 of DOPT OM dated 05-04-2010),
- (iv) those Commissioned Service Officers who retired and re-employed after 01-01-2006 (revised Para 4 (d) (ii) and 4 (b) (ii) of DOPT OM dated 31-07-1986 as mentioned in para 2 of DOPT OM dated 05-04-2010).

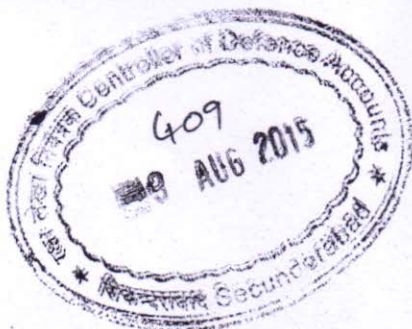
2. In view of the above, the provisions stipulated in DOPT OM dated 05-04-2010 categorically cater for the manner of pay fixation on re-employment in respect of all categories of re-employed ex-servicemen. The related cases of pay fixation may be dealt with accordingly.

3. Further, para 4 of DOPT OM dated 05-04-2010 states that the existing instructions on the subject shall be treated as amended to the extent of provisions of DOPT ibid OM. Hence for any contradictions between the provisions of DOPT OM dated 11-11-2008 and 05-04-2010, the contents of DOPT OM dated 11-11-2008 stand amended to the extent of the contradiction.
