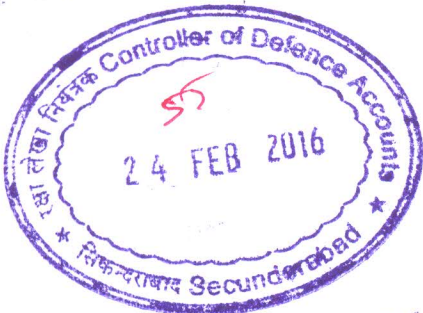
Subject - Expenditure Management with reference to RE 2015-16.
