विषय / Sub : Restoration of ration in kind in lieu of Ration Money Allowance to the Officers of Defence Forces posted in peace areas.


संदर्भ / Ref : GoI, MoD GSL No. 3(01)/2016/D (QS) dt 7th Aug 2019

GoI, MoD vide letter under reference has restored 'ration in kind' to officers of Defence Forces posted in peace areas with immediate effect and requested to make immediate necessary arrangements for providing ration in kind as per their entitlements.

02. Since there is no provision regarding availability of option to Army officers to opt and select RMA or Ratio in kind in lieu of RMA in above GSL, HQrs CGDA has requested IHQ of MoD (Army) to obtain specific approval for providing choice for opting RMA or Ratio in Kind from MoD in prior. Accordingly, all officers of Defence Forces posted in peace areas, except as per provisions of Rule 174

of DSR Pay and Allowance Regns Officers Army (1954 Edn), are requested to draw 'ration in kind' as per their entitlement.

This issues with the approval of CDA.
