



Subject: Circulation of various Government orders/instructions issued by the Nodal Ministries

From time to time, various Government orders are issued by the Nodal Ministries on various subjects. As per practice, these are circulated by the Ministry of Defence to the Defence Establishments/Directorates for information/compliance.

2. Some Defence Establishments have remonstrated that there is considerable time lag between issuance of orders by the Nodal Departments and their re-circulation by the MoD. It is on account of the fact that the Nodal Ministries/Depts have discontinued the general practice of physical circulation of their Orders/OMs to the Ministries/Departments of Govt. of India. Nodal Ministries/Departments now upload their new Orders/instructions on their official website and therefore, copies of new orders/instructions of Nodal Ministries/Departments are not being received in MoD.

3. It has been observed that all the orders/instructions on the subject of CCS (LTC), CS (MA), CGHS, CCS (Pension), ACP/MACP, etc are applicable to Defence Civilian Employees in original form. These are circulated to lower formations of MoD in their original form, without any changes. To streamline this task in accordance with the new practice now adopted by the Govt Ministries/Departments, it has been decided to discontinue the existing practice of circulation of each & every order/instruction to all the lower formations. Defence Establishments/Service Headquarters/lower formations of MoD are advised to download such Government orders from the website of Nodal Ministries, which are applicable to Central Government employees, including Defence Civilian employees, in the original form for further necessary action. Those Govt orders/instructions which are not applicable to Defence Civilians in their original form would continue to be circulated, after obtaining the approval of competent authority, by D(Civ). Besides reducing the avoidable paperwork, this would also help in faster dissemination of the new Government orders/instructions and in their expeditious implementation.
