HQrs Ofice vide their letter under reference has intimated that it has come to their notice that booking against expenditure incurred for payment of outsourcing of conservancy service in Non-Cantonment Military Stations are being made under code head 560/00 Sub Head A, Minor Head 800, Major Head 2076.

It was also intimated that a new code head 599/06 has been introduced in CHB for the purpose of booking of expenditure in r/o "conservancy services" under Sub Head – G. Outsourcing under Minor Head 800 – Other Expenditure, Major Head 2076 – Defence Services - Army vide CS No. 06/2020.

In view of the above, newly introduced code head 599/06 may be utilised for booking of expenditure for "conservancy services" strictly as referred at para 2 above.

Sub: Clarification of code head for conservancy services.
