Subject: Transfer Estt. DAD –SAOs/AOs– Annual List of Volunteers (Within the Organisation).

HQrs office vide Lr. No. AN/II/2153/2009-AOGE dt. 26.06.2019 & revised circular dated 04.10.2019 has empowered the PCsDA/CsDA/PCA(Fys) to carry out rotation/transfer/posting of SAOs/AOs (including AO GEs/ AO BRTFs) within their command/jurisdiction w.e.f. 01.07.2019.

- 2. HQrs office vide their letter No. 0600/AN-X/Vol,XXI dated 28.03.2014 has circulated transfer policy approved by the Competent Authority to be followed by the CGDA's Office and field PCsDA/CsDA while carrying out transfers of the members of the Department excluding IDAS officers, from one station to another.
- 3. In view of the guidelines enumerated in the HQrs letters mentioned above, it has been decided by the Competent Authority to call for volunteers amongst SAOs/AOs for posting/transfer to their choice station within the CDA Secunderabad jurisdiction.
- 4. Accordingly, the details of volunteers amongst SAOs/AOs serving in your office/group for transfer to their choice stations within the organisation may please be forwarded to this office, in the prescribed format enclosed as Annexure-A, along with the necessary declarations so as to reach this office on or before 30.06.2022. Applications in respect of SAOs/AOs who have not completed two years in the station are not to be entertained/forwarded.
- 5. Further, the volunteers may be informed that the application for transfer to their choice station would be considered subject to availability of vacancy, administrative feasibility and discretion of the Competent Authority ONLY. The Competent Authority will also have the discretion to cancel / withhold the Volunteers List on administrative exigencies at any point of time.
- 6. Applications received after <u>30.06.2022</u> may not be forwarded.
