It gives us immense pleasure to inform that Hon'ble CGDA Shri Rajinish Kumar has launched Gyan Sudha 2.0 Portal on 18.05.2022 at National Academy of Defence Financial Management Pune.

2. वर्ष 2018 में ज्ञान सुधा पोर्टल, अपने विकास के बाद से, हमारे विभाग के अधिकारियों और कर्मचारियों को स्व-पुस्तक ई-लर्निंग प्रदान करने में अत्यधिक उपयोगी रहा है। आज तक, कुल 5700 उपयोगकर्ता प्लेटफॉर्म पर पंजीकृत हैं और इसे लगभग प्राप्त हुआ है। उपयोगकर्ताओं द्वारा ग्यारह लाख हिट प्राप्त हुआ है । वर्तमान में पोर्टल पर 300 से अधिक वीडियो होस्ट किए गए हैं।

Since its development in the year 2018. Gyan Sudha Portal has been immensely useful in imparting self-paced e-learning to the officers and staff of our Department. As on date, total 5700 users are registered on the platform and it has received appx. Eleven lakhs hits by the users. More than 300 videos are presently hosted on the portal.

3. जान सुधा की तुलना में ज्ञान सुधा 2.0 में किए गए महत्वपूर्ण उन्नयन की संक्षिप्त तुलना अनुलग्नक 'A' के रूप में संलग्न है। ज्ञान सुधा 2.0 की विस्तृत विशेषताएं और उपयोगकर्ता नियमावली अनुलग्नक 'वी' और 'मी' के रूप में संलग्न की गई है। यह भी सूचित किया जाता है कि ज्ञान सुधा 2.0 का एक परिचयात्मक वीडियो यूट्यूव चैनल "रक्षा लेखा विभाग, रक्षा मंत्रालय" पर भी उपलब्ध है और 20-05-2022 को प्रकाशित किया गया है। Brief comparisons of important upgradation made in Gyan Sudha 2.0 vis-à-vis Gyan Sudha are enclosed as Annexure 'Å'. Detailed features and User Manual of Gyan Sudha 2.0 have been enclosed as Annexure 'B' and 'C. It is also informed that an introductory video of Gyan Sudha 2.0 is also available on YouTube channel "Defence Accounts Department. Ministry of Defence" and published on 20-05-2022.

It is further requested to motivate all the officers and staff to register under Gyan Sudha 2.0 portal. So that 100% Registration of Staff and Officers under your jurisdiction is achieved.

#### Annexure B

### 1. Admin Module

a. In existing Gyan Sudha there was only one system administrator who had access to approve new registered users or add new faculty or new client controllers.

In Gyan Sudha 2.0 a new user Institute Admin has been created. This user will have access to approve new registered users or add new faculty or new client controllers for respective Institute.

b. In existing Gyan Sudha there was an E-Sankalan which had Codes and Manuals.

In Gyan Sudha 2.0 Knowledge Centre has been created which has provision to add subject wise and function wise repository of all training resources and chronologically linked govt orders.

c. In existing Gyan Sudha provision to add qualification of faculty was not available.

In Gyan Sudha 2.0 provision to add additional information like qualification and domain of expertise has been created as suggested by committee members.

**d.** A database will be created to store information of all DAD offices situated in India.

Repository of faculties of all RTCs. A database for DAD and non-DAD faculty will be created and contain all useful information about a faculty.

#### 2. Coordinator Module

**a.** In existing Gyan Sudha there was a provision to add new client controller and their sub offices.

In Gyan Sudha 2.0 a database of all controller's offices and sub offices has been created.

**b.** In existing Gyan Sudha there was no provision to edit the courses once created also whenever the same course is repeated there was no provision to use

already existing tutorials and question papers i.e. all tutorials were uploaded again.

In Gyan Sudha 2.0 new features like edit existing courses, subject contents and use of existing courses and tutorials available in Knowledge Centre has been made.

**c.** In existing Gyan Sudha the participants were able to directly attempt assignments, multiple choice questions, feedback to generate certificates without going through tutorials.

In Gyan Sudha 2.0 provision for tracking of user has been made so that user will not be able to directly attempt assignment or MCQs without watching the tutorials. In addition, there is a provision to track attendance of users also.

**d.** In existing Gyan Sudha all tutorials were uploaded under a course therefore, Coordinator was not able to use one tutorial for more than one course.

In Gyan Sudha 2.0 Coordinator tutorial database is independent of any course therefore, Coordinator will be able to use one tutorial for more than one course.

e. In existing Gyan Sudha all question banks were uploaded under a course therefore, Coordinator was not able to use same question for another course.

In Gyan Sudha 2.0 an independent MCQ database has been created. Now Course Coordinator will be able to choose questions form MCQ database to new exam. Moreover, provision to add subjective questions is also made available in Gyan Sudha 2.0.

f. In existing Gyan Sudha there was a discussion forum where any Gyan Sudha users can raise department related query, which can be replied by faculty member or any registered user.
In Cuery Sudha 2.0 there are two types of Discussion forum.

In Gyan Sudha 2.0 there are two types of Discussion forum :-

- 1. Open discussion forum common to all.
- 2. Specific the course.

#### 3. User Module

**a.** In existing Gyan Sudha registered users have common discussion forum, E sankalan (codes and manuals of DAD), nominated courses, tutorials, and practice test.

- **b.** In Gyan Sudha 2.0 registered users will have Knowledge Centre with subject wise and function wise repository of training material.
- c. SAS training material and practice test are placed separately.
- d. Provision for self-paced learning and generation of certificate to the effect
- e. In existing Gyan sign-up page was limited to only office details and personal account no. more over options like edit/update profile and forget password was not available.

In 'Gyan Sudha 2.0' sign-up page is user friendly and registered user can edit/update their profile information, add their field of interest and domain of expertise. Registered users can use forget password to reset their password in case they forget their password.
