Subject : Selection of AAOs to serve as faculty in RTC Lucknow.

Hqrs office vide letter cited under reference has called for volunteers amongst AAOs to serve as Faculty for imparting training to the officers and staff at RTC Lucknow.

2. The volunteers must have good skills and proven aptitude for training. Before appointment to the post of training faculty in RTC Lucknow, the volunteering Officers would have to undergo screening test to be conducted by Screening Committee, constituted by Hqrs office and those selected will be eligible for training allowance in accordance to extant rules.
3. A "cooling off period" of 3 years is required to be completed for considering the candidature of Officers for serving as faculty, who have earlier served/serving as faculty.
4. A minimum stay of 2 years at present station or prescribed length of tenure for hard and tenure station would require to be completed by the volunteer officers before being eligible for the post of faculty in training centre.
5. The Officers applying for the post of faculty should not have applied for other panel for transfer to Bhutan / Tajikistan, J&K Region, North East Region, Andaman & Nicobar Islands etc.,
6. The Officers applying for the post of faculty should have minimum residual service of 02 years as on 31.10.2024.
7. Interested AAOs may forward their application in the format enclosed as Annexure-A, so as to reach Main Office on or before **14.10.2024** for onward transmission to Hqrs Office.
8. 'NIL' Report is also required.
