Name of Post	Accounts Officer
Terms & Conditions	The Officer is required to undertake works related to finance and accounts for officers posted with SSQAG and handle documents related to other financial transaction of the establishment.
Pay Scale Admissible	The pay scale admissible will be as drawn by the individual in accordance with the existing Central Government pay scales (PB1, PB2, PB3 and PB4 as applicable). There will be no change in pay scales of the individual on account of joining SSQAG. Deputation allowance is admissible as per the extent orders/guidelines issued from time to time.
Duration of Deputation	Deputation tenure may be for an initial period of 03 years and as per the provisions issued on the subject from time to time.

Therefore, it is requested to forward names of willing SAOs, who have completed minimum stay of 02 years in the present station, having residual service of at least 4 years as on 25.12.2024 and also completed mandatory "Cooling off" period of three years in case the Officer has recently served on a deputation post, to this Office latest by **27.12.2024** for onward transmission to HQrs.
