- 2. Ministry has intimated that Special Campaign 5.0 for improving Swachhta and disposal of pending references shall be carried out from 02nd October, 2025- 31st October, 2025 along the lines of the Special Campaigns held in 2021, 2022, 2023 and 2024 in two phases viz:
 - (i) Preparatory Phase from 15th September, 2025 to 30th September, 2025
 - Targets are to be fixed against various parameters mentioned at Para 3 in above ID note.
 - (ii) Implementation Phase from 02nd October, 2025 to 31st October, 2025
 - All out efforts have to be made to achieve the targets fixed in preparatory phase and information has to be provided to HQrs. on daily basis by 12:30 PM without fail.
- 3. High resolution pictures and videos (maximum one-minute length) of campaign sites before start of campaign and after completion of the campaign are to be captured and forwarded to HQrs.

- 4. Two innovative best practices are to be devised and implemented in your Swachhata related activities during campaign and the same is to be intimated to the HQrs. by 19.09.2025.
- 5. The format for reporting target and disposal/achievements and the Swachhata drive shall be shared shortly.
- 6. GO(AN) in your organisation will be the Nodal officer and will be personally responsible for carrying out the campaign and for timely submission of the report to HQrs.

DAR& PG vide their O.M No. Q-11011/01/2025-O&M (e-9571) dated 1st August, 2025 has intimated that Special Campaign 5.0 for improving Swachhata and disposal of pending references from 02nd Oct. 2025 to 31st Oct, 2025 shall be carried out across all the Ministries/Departments along the lines of the Special Campaigns held in 2021, 2022, 2023 & 2024. The Special Campaign 5.0 shall consist of two phases viz. (i) Preparatory Phase from 15th September, 2025 to 30th September, 2025 during which targets against various parameters mentioned at Para 3 below are to be decided by the Departments and (ii) Implementation phase from 2nd October, 2025 to 31st October 2025 during which all efforts has to be made to achieve the targets identified/fixed in preparatory phase and information thereon has to be provided on daily basis.

- The focus area of the Special Campaign 5.0 this year shall be "disposal of e-waste 2 generated in Government offices" in compliance of E-waste Management Rules 2022 issued by M/o Environment, Forest and Climate Change. Overall cleanliness of Government offices with special focus on space management and enhancing work place experience of field offices is to be undertaken during the Special Campaign.
- Information on following parameters is required to be collected during the 3. preparatory phase: -
 - Identifying number of pending References from MP's
 - Identifying pending references from the State Governments
 - Identifying pending Inter-Ministerial References (Cabinet Note)
 - Identifying Parliamentary Assurances pending more than 3 months.
 - Identifying pending PMO references
 - Identifying number of Rules / Processes, if any, for simplification
 - Identifying pending public grievances (CPGRAMS as well as grievances received from other sources)
- Record Management- Review of files/ recording and weeding of files/ closing of e-
 - Identification of Cleanliness Campaign sites



- Planning for space management and beautification of offices
- Identifying scrap and redundant items and their disposal procedure as per GER
 - Identifying the e-waste items and ensuring their disposal as per the procedure laid down by the Ministry of Environment Forests and Climate Change.
- D(O&M) is mandated with compiling and entering the statistics/ data for Department of Defence (DoD) on the dedicated portal of DAR &PG designed for this purpose. As along the lines of previous years, following Sections/Divisions are hereby nominated for providing consolidated data/statistics for their respective wings including the Attached/Subordinate offices under their administrative control to D(O&M), which are as follows:
 - a) D(JCM) for JS(Estt.) Wing and D(Med) for JS(Med) Wing
 - b) D(Navy-II), D(CSD) & D(AF) for JS(AF) Wing: D(CG) for JS(CG) Wing
 - c) D(Lands). D(Q&C). D(Works-II) for JS(L&W) Wing: D(SSC) for JS(SSC) Wing
 - d) D(BR-II) for JS(BR) Wing
 - e) D(Coord) for JS(Coord) Wing
 - f) D(GS-II) and D(GS-VI) for JS(Trg) Wing
 - g) D(GS-IV) for JS& AM(LS) Wing: PO(Sys) for JS & AM(MS) Wing:
 - h) Planning Division for JS(Planning) Wing.
 - j) D[Air(Acq)] & D[Air-II] for JS&AM (Air) Wing.
 - k) D(Parl) for Parliamentary Assurances for entire DoD.
 - l) D(PG) for Public Grievances status on CPGRAMS for entire DoD.
 - m) D(Estt.II/Genl. I) for identification of cleanliness campaign sites, space management planning/space freed and scrap disposal (amount generated) in MoD(Secretariat).
 - n) O/o CAO to communicate their consolidated data directly to D(O&M).
- 5. 100% Saturation approach in concomitant Swachhata Abhiyan is advised. The field/outstation offices are therefore to ensure high resolution pictures and videos (maximum one-minute length) of the Campaign sites before start of Campaign and after completion of the Campaign for documentation purposes and showcasing during the Good Governance Week. 2025 Efforts are to be made to capture the feedback of beneficiary/ common public on these efforts in pictures and videos. For Department of Defence, all the Cantonments, projects under Border Roads, the Sainík Schools, Military Hospitals, Depots under Canteen Stores Department, field offices of Controller General of Defence Accounts, Coast Guard stations, field offices of NCC, four mountaineering institutes etc. shall be the principal focus areas for the Swachhata drive during the implementation phase of the Campaign. All these offices are, therefore, required to devise and implement at least two innovative best practices in their Swachhata related activities during the Campaign and inputs/write-ups on the same may be shared with D(O&M) by 06th Oct, 2025 without fail. Photographs and videos of these best practices may also be kept readily available.

- A Hashtag #Special Campaign 5.0 shall be created by DAR & PG shortly. At the attached and subordinate offices are required to tweet the Swachhata Abhiyan activities [photographs and short one-minute video clips] on regular and consistent basis during the implementation phase against the hashtag # Special Campaign 5.0. The URLs of the tweets so made may be shared with D(O&M) in an excel sheet on weekly basis, preferably every Monday, during the implementation phase of the Campaign i.e. on 06th Oct, 13th Oct, 20th Oct, 27th Oct, and 3rd Nov.
 - It may be appreciated that the progress shall be frequently reviewed by Secretary DARPG with the Nodal Officers during the Identification Phase as well as during the Implementation Phase. Third party assessment of campaign is also to be undertaken during the post-Campaign phase (17th November-30th November, 2025).
 - 8 All the Wing Heads of DoD are, therefore, requested to -
 - under their administrative control to carry out the Special Campaign 5.0 in right earnest, including the concomitant Swachhata Campaign, and put in place an institutional mechanism and direct the concerned administrative Sections as well as the concerned Nodal Officers for the Attached/ Subordinate Offices to ensure unhindered flow of statistics/data/pictures/videos/best practices/other details on Swachhata as detailed above during the preparatory as well as implementation phase of the campaign to D(O&M).
 - DGAFMS DGBR, DGDE. Sainik School Society, DG-NCC, HQ-ICG, HMI and convey their details (name, designation, mobile number) to D(O&M) latest by 02nd Sep, 2025. The Nodal Officer snall be entrusted with the primary responsibility of overseeing the Swachhata drive in all the outstation offices during the Campaign and reporting pictures/videos/best practices/tweets/other details on Swachhata accordingly to D(O&M)
 - direct the concerned Administrative Sections under their Wings mentioned at Para 04 above to make a **realistic assessment** of the **targets** (i.e. only such targets which can be fulfilled) **against various parameters during the preparatory phase** mentioned at Para 03 above including the attached/subordinate offices, and finalize the same:
 - (d) direct the concerned administrative Sections under their Wings to compile and convey the statistics/data including the attached/outstation offices, on the disposal (also



called achievements) during the implementation phase (2nd October, 2025 to 31st October, 2025) on daily basis by 3:00 PM, without fail to D(O&M) so as to enable D(O&M) to consolidate the same and enter into the portal on behalf of DoD

- The format for reporting target and disposal/achievements of data/statistics and the 9 Swachhata drive shall be shared shortly with all the administrative sections and the attached offices once the portal for Special Campaign 5.0 becomes operational
 - The information/inputs/write ups shall be shared with D(O&M) at dedicated emails 10 re. sodom-mod@gov.in, usdpg-mod@gov.in and dsmis-mod@gov.in
