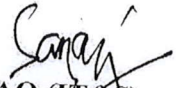
Sub: Implementation of NIDHI 2.0

In continuation to the letter referred to above, it is hereby informed that the competent authority has directed the full complete rollout of NIDHI 2.0.

2. NIDHI 2.0 deals with all the activities related to GPF management of DAD and Non-DAD employees. The GPF data would automatically be received from TULIP and TULIP-PMS using API.
3. NIDHI 1.0 has been stopped with immediate effect and shall no longer be used for any activities pertaining to GPF management. There is no requirement for sending subscription data to CDA(Funds) Meerut for the applications using NIDHI API i.e. TULIP, TULIP PMS, P&C Portal except PAO(GREF).
4. In view of above, it is requested to disseminate this information to all sub offices under your jurisdiction to ensure smooth implementation of NIDHI 2.0.
