Sub: NPS - Coverage under CCS (Pension) Rules 1972 in place of NPS for employees whose selection for appointment was finalized before 01.01.2004 but who joined Government service on or after 01.01.2004-Reg.

Ref: This office letter no. No. NPS Cell/Circular/2020 dated 12.03.2020.

Please refer to this office circular letter referred above on the above mentioned subject.

As per para (8) of DoP&PW OM No. 57/04/2019-P&PW (B) dated 17<sup>th</sup> February, 2020, the matter regarding coverage under the CCS(P) Rules 1972 based on the option exercised by the government servant shall be placed before appointing authority for consideration in accordance with these instructions. In case the Government servant fulfils the conditions for coverage under CCS (Pension) rules 1972, in accordance with these instructions, necessary Order in this regard shall be issued latest by 30<sup>th</sup> September, 2020. The NPS account of such Government servants shall, consequently, be closed w.e.f, 01<sup>st</sup> November,2020.

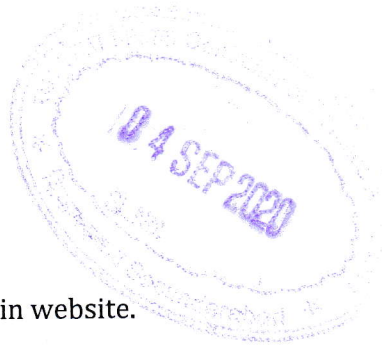
It is requested to kindly send the Orders containing names of the Government servants, who have exercised their option for coverage under CCS (Pension) rules,1972 and fulfils the conditions under CCS (Pension)rules, 1972 and has been approved by the appointing authority for enabling this office to take necessary action w.r.t closing of NPS account w.e.f 1<sup>st</sup> November, 2020.

The above instructions of DOP&P OM No. 57/04/2019-P&PW (B) dated 17<sup>th</sup> February, 2020 and the timeline mentioned therein i.e., 30<sup>th</sup> September, 2020 for issuing of orders for switching over CCS (Pension) rules,1972 and 1<sup>st</sup> November 2020 for closing NPS account, may strictly be adhered to and no relaxation in the dates may be made at a later date.
