(i) Educational qualification & Criteria for Deputy Controller of Accounts: In Case of Deputation: Officers working as Deputy Controller of Accounts or equivalent in the Central Government or State Government or court or tribunal in the grade pay of Rs. 6600/- or officers in grade pay of Rs. 5400/- i.e. Level-9 in the Pay Matrix with five years regular service or grade pay of Rs. 4800/- i.e. Level-8 in the Pay Matrix with six years of regular service or seven years of regular service in the grade pay of Rs. 4600/- i.e. Level-7 in the Pay Matrix or in the grade pay of Rs. 4200/- i.e. Level-6 in the Pay Matrix, with ten years of regular service in the field of accounts, budget, cash in a Government office or public sector undertaking or autonomous body or statutory body.

Note 1:- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2:- Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other

Desirable: (i) A pass in Subordinate Account Service examination conducted by any of the Organised Accounts Departments of the Central Government or State Government:

- (ii) Successful completion of training in cash and accounts work in ISTM and experience in handling cash; accounts and budget work.

- Note 2:- Period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily be three years. The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of applications.
