
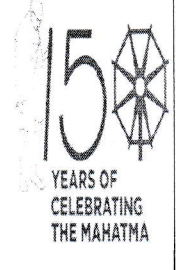

विषय /Sub : Prompt payment to suppliers under GeM to avoid penal interest.

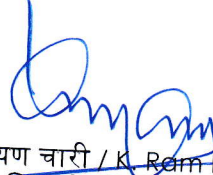
संदर्भ / Ref : This Office Imp GeM Circular of even No dt. 26th Aug 2020 and dt. 23/09/2020

Kindly refer this office Imp GeM Circular dt. 23/09/2020, where in it was intimated that whenever a CRAC is autogenerated or issued by a buyer and payment is not made 10 days thereafter, the buyer organization is required to pay interest @ 1% per month for the delayed payment beyond the prescribed timeline till the date of such payment.

02. All out efforts are being made to release the payment to vendor by this office in r/o GeM procurements, subject to procurement of goods and services by the Units / Formations as per the provisions of GFR 2017, DPM 2009 and other orders issued by Gol from time to time and fulfillment of audit requirements by the Units while submitting the GeM bills.

03. Keeping in view of Gol intent for prompt payment to Vendors in r/o GeM procurements and also to avoid penal interest on delayed payments, it is requested that all rejected bills either online or offline by this office or bills failed to receive in this office after process by Units due to technical reasons, may kindly be put up to OC / CO of the Unit to get the attention of higher management, so that the rejected GeM bills can be submitted to this office as fast as possible duly rectified the observations.

This issues with the approval of CDA.


