Grant of Financial up-gradation under MACP Scheme in respect of DEOs

consequent upon re-fixation of pay scale of DEOs A in the pay scale of

Rs.1150-1500 in DAD - Reg.

HQrs. Office vide letter cited under reference has clarified that DEOs (non applicants of the court cases regarding financial up-gradation under ACP Scheme) are entitled only to benefits of  $1^{\rm st}$ ,  $2^{\rm nd}$  &  $3^{\rm rd}$  financial up-gradation under the provisions of MACP Scheme in the pay level of 5, 6 & 7 of pay matrix of  $7^{\rm th}$  CPC respectively (corresponding GP 2800, GP 4200 & GP 4600 under  $6^{\rm th}$  CPC) as the case may be, in terms of Supreme Court judgement dated 09/12/2014 against Civil Appeals No.10862 to 10867 of 2014.

- 2. It is also clarified that the change/transfer from DEO Cadre to general stream of clerical cadre granted earlier to DEO A on passing SAS Part I Examination by exercising an option may be treated as promotion for the purpose of granting financial up-gradation in the prevailing scenario, therefore 2<sup>nd</sup> MACP/3<sup>rd</sup> MACP may be regulated as per extant orders on the subject.
- 3. HQrs. Office has further clarified that regarding the cases pertaining to the applicants (DEOs) involved in the court cases related to financial up-gradation under ACP Scheme, the decision will be conveyed only after finalisation of SLPs pending in the Apex Court.
- 4. In view of the above, the clarifications on the subject received from HQrs. Office may be circulated amongst all the DEOs working in your office and an Undertaking in the proforma enclosed to this letter may please be obtained from them and the same may please be forwarded to Main Office latest by **05.06.2020** to enable this office to grant MACP.
