- iv) Request for a particular choice station, if any, from the AAO with relevant information regarding family problems, medical reasons etc. (duly supported with documents) that the officer may like to mention in support of his/her request for posting to a particular station on promotion to AO's Grade for consideration of the Competent Authority (copy enclosed)

In connection with **(iv)** above, it has been directed to bring to their notice that it should not be viewed as a promise to post them at their choice stations. The posting will be decided duly considering the information supplied by them and, therefore, no further representation for change of posting will normally be entertained once the promotion orders are issued by the HQrs, unless the request is for forgoing the promotion. No further representation for change of posting on promotion should, therefore, be forwarded unless it is for forgoing promotion or warranted by some unforeseen later developments. Further, since the circumstances of the eligible AAOs who have given choice stations earlier, might have changed, fresh applications are required to be submitted in respect of each eligible AAO falling in the zone of consideration so that while deciding their postings, the latest grievances/problems mentioned by them be kept in view for considering their posting on promotion to AO's grade.
