Subject: Implementation of recommendation of 7th CPC - Para 11.12.140 - Grant of Grade pay of Rs. 5400/- (PB 2) i.e. Level 9 of Pay Matrix in case of Assistant Accounts Officer of Defence Accounts Department of Ministry of Defence.

CGDA New Delhi Office letter No. AN/XIV/14162/7th CPC/Vol.II Dt. 13.11.2020 have conveyed the sanction of the GoI, Ministry of Finance, Department of Expenditure vide its OM No. F. No. 25-2/2017-IC/E III(ii) Dt 06.11.2020 on the above subject in pursuance of the recommendations of 7th CPC as contained in para 11.12.140 of the Report and Government No. G.I, M.F. No. 1-2/2016-IC Dt. 25th Jul, 2016.

2. In accordance with the ibid O.M. the revised pay scale of the post of Assistant Accounts Officer in Defence Accounts Department would be in Level 8 of Pay Matrix and Level 9 on completion of 4 years in Grade Pay of Rs. 4800/- (PB-2)/Level 8.

3. In accordance with the above, approval of the Appointing Authority is hereby accorded for grant of Non-Functional Upgradation in r/o AOs/AAOs mentioned in Annexure-A and B in Level 9 of Pay Matrix of 7th CPC with effect from the date indicated against them.

4. This is a Non-Functional Upgradation (NFU), which is subject to the following terms and conditions.

- i) The grant of NFU will be admissible on completion of 4 years of regular service in the cadre from the date of joining as AAO. The aforesaid Non-Functional Upgradation (NFU) to AAOs is effective from 01.01.2016.
- ii) The NFU will be subject to vigilance clearance. The AAOs mentioned in Annexure-A & B to this Part-II Office Order are clear from Vigilance angle.
- iii) Benefit of Pay Fixation as per Rule 13 of CCS (Revised Rules) 2016 shall be available at the time of grant of Non-Functional Upgradation to AAOs. **Option for pay fixation may be exercised within one month of issue of this order (Option form enclosed).**
- iv) After the grant of NFU to AAOs in Pay Level-9 and their pay fixation under Rule 13 of CCS (RP) Rules 2016, there will be no further pay fixation on promotion to the post of Accounts Officer in Pay Level-9.
- v) NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS).
- vi) This supersedes all earlier Part II Office Orders on MACPS already granted to the affected AAOs after 01.01.2016 in Pay Matrix Level-9.
