

Subject: Action on anonymous / pseudonymous complaints.

The undersigned is directed to state that instructions regarding dealing with anonymous and pseudonymous complaints are issued by DoPT/CVC time and again prescribing that no action is required to be taken on anonymous / pseudonymous complaints, irrespective of the nature of the allegations and that such complaints need to be simply filed. The said instructions contained in DoPT O.M. dated 18.10.2013, 18.06.2014, 31.03.2015 and CVC circular dated 25.11.2014, 07.03.2016 may kindly be referred.

2. Nevertheless, a large number of anonymous / pseudonymous complaints are received in this HQrs Office. After careful examination of the said complaints, it has been observed that no action on such complaints is to be taken. Thus, corrective measures could not be taken on the said complaints being anonymous / pseudonymous in nature. Moreover, it has also been observed that some allegations are levelled in the complaints without any concrete detail/proof and are made merely to tarnish the image of officials of the department.

3. Since most of these complaints are made by some disgruntled employees, as is apparent from the allegations levelled in such complaints, it is, enjoined upon all to ask every employee under their administrative control to desist from making anonymous/pseudonymous complaints against any official of this department. Instead, all PCDA/CDA and equivalents are requested to kindly encourage their employees to prefer their complaints in their names with full details supported with documentary evidence so that corrective action is taken, if required and the defaulters are also penalised.
