
Sub: Reimbursement of RME claims in r/o. COVID-19 treatment – Reg.

OFFICE MEMORANDUM

Sub: CGHS rates for treatment at private healthcare organizations empanelled under CGHS –in view of the COVID-19 Pandemic

With reference to the above mentioned subject the undersigned is directed to state that In view of the current Corona Virus Disease(COVID-19) Pandemic this Ministry is in receipt of representations seeking clarifications and guidelines regarding rates applicable for treatment in private healthcare organizations empaneled under CGHS. This matter has been reviewed by the Ministry and it is now decided to issue guidelines and rates for treatment / investigations at private healthcare organizations empanelled under CGHS as per the details given under:

2. a) CGHS rates for **treatment for COVID-19** in private empanelled hospitals in respect of CGHS beneficiaries in a City shall be as per the **package rates prescribed by the concerned State Government**. In case no such rates have been prescribed by the State Government in any CGHS City, the rates prescribed by Govt. of NCT Delhi shall be applicable, till rates are notified by the concerned State Government.
- b) For non COVID related treatment in private hospitals empanelled under CGHS the Normal CGHS package rates shall be admissible. CGHS beneficiary shall undergo COVID-19 test as per the approved rate before elective treatment procedure.
- c) For treatment under emergency – the patient shall be treated in Isolation ward till the COVID-19 test results is not available and rates as per isolation ward rates for one day shall be applicable.

If the beneficiary is COVID-19 negative, he/ she shall be shifted to normal wards and normal CGHS rates will be applicable and if COVID-19 positive, he/she shall be under treatment in COVID ward and prescribed rates shall be applicable.

- d) COVID test shall be permitted as per ICMR guidelines, and CGHS rate shall be as per the rates fixed by concerned State Government or actual, whichever may be less. If State Government has not notified such rates in any CGHS City, the rates prescribed by ICMR are applicable till rates are notified by State Government.

3. It is once again reiterated that all CGHS empanelled hospitals , which are notified as COVID-Hospitals by State Governments shall provide treatment facilities to CGHS beneficiaries as per the CGHS norms and as per the rates prescribed above , for all COVID related treatments.

Similarly, it is again reiterated that all the CGHS empanelled hospitals, which are not notified as COVID Hospitals shall not deny treatment facilities / admission to CGHS beneficiaries and shall charge as per CGHS norms, for all other treatments.

Suitable action shall be taken in case of violation of the guidelines.

CGHS empanelled healthcare organizations shall perform the treatment / test on Cashless basis in respect of pensioners, etc., and submit the bills to CGHS through UTI-ITSL. The reimbursement for the cost of expenditure on the test at approved rate shall be reimbursed by concerned Ministry / Department / Organization in respect of serving employees and beneficiaries of Autonomous Bodies.

4. These orders come into effect from the date of issue till further orders.

5. This issues with the concurrence of Integrated Finance Division, MoHFW vide CD No 805 dt 10.07.2020.

Health Medical and Family Welfare Department-COVID-19-Fixation of ceiling on rates chargeable by Private Hospitals and Private Laboratories for treatment and testing-Orders - Issued.

HEALTH MEDICAL AND FAMILY WELFARE(D) DEPARTMENT

ORDER:

The Government of Telangana has been taking various measures to combat COVID-19 pandemic. The Government is providing free testing and treatment in the Government hospitals. However, in view of a number of public grievances regarding exorbitant rates being charged by private health care providers, the Government has decided to fix ceiling on the rates chargeable by private health care providers for providing testing and treatment services to COVID-19 patients.

2. The Government after careful examination of the matter, and in terms of the provisions given in the references read above, hereby order to fix maximum rates chargeable by private hospitals for various services provided by them for COVID-19 treatment. Ceiling on prices as shown below shall be followed with immediate effect.

Package	Rate in INR per day	Inclusions	Exclusions
Charges for Routine ward + Isolation	4000	This includes Monitoring and Investigations like CBC, Urine routine, HIV spot, Anti HCV, Hbs Ag, Serum Creatinine, USG, 2D ECHO, X-Ray, ECG, Drugs, Consultations, Bed Charges, meals. Procedures like Rylestube insertion, urinary tract catheterization.	Does not include: 1. PPE 2. Interventional procedures like, but not limited to, Central line insertion, Chemoport insertion, bronchoscopic procedures, biopsies, ascitic / pleural tapping, etc, which may be charges at a rack rate as on 31 st Dec 2019. 3. COVID-19 testing - to be done as per actual cost as fixed by the state Government i.e., Rs.2,200. 4. High end investigations like CT-SCAN, MRI, PET scan or any lab investigation not included in the previous column - to be charged at rack rates of hospital as on 31 st December 2019.
Charges for ICU without ventilator + Isolation	7500		
Charges for ICU with ventilator + Isolation	9000		

3. The Private hospitals shall display the above rates at prominent places in their premises. It is the duty of the concerned private hospital to explain the patient/relatives about charges for various services.

4. It has come to notice that many asymptomatic and mild symptom cases are being admitted in the hospital facilities. Attention is invited to the guidelines issued by the Ministry of Health & Family Welfare, Government of India, which clearly state that Asymptomatic and mild symptom cases do not need hospitalization and are either recommended to be kept under home isolation, following the guidelines issued previously by the government for home isolation or be sent to COVID care centers if their houses are not suitable for home isolation. All private hospitals are hereby directed to scrupulously follow these guidelines.

5. The Indian Council of Medical Research (ICMR) has permitted some of the private laboratories to do COVID-19 tests. Private laboratories shall test strictly following the testing protocols issued by the ICMR as updated from time to time. Further the Government, in terms of the provisions given in the references read above, hereby fix the following maximum rates chargeable for testing (RT-PCR) by the above private laboratories:

Maximum Rates Chargeable for RT-PCR TEST	
Samples which are collected at the Labs/Hospitals	Rs.2,200
Samples which are collected from home	Rs.2,800

6. All private health care providers - both hospitals & laboratories should enter the real time data on the digital platform developed by the Government of Telangana @ www.chfw.telangana.gov.in. The private hospitals shall apply to Director Public Health for permission to treat COVID-19 patients. The Director of Public Health shall issue the necessary user credentials and passwords after due scrutiny. As and when a positive case is detected, case detail has to be immediately entered into this portal by the private laboratories to enable immediate tracing of contacts and taking further action. Similarly, when a COVID-19 positive patient is admitted in a private hospital, the private hospital shall enter the details in the above portal.

7. All private health care providers shall strictly follow the guidelines issued by ICMR on testing and clinical management & discharge guidelines issued by Ministry of Health & Family Welfare, GoI as updated from time to time. In the public interest, they shall restrain from aggressive marketing.

8. All Hospital are directed to strictly comply with the above orders. Non-Compliance shall attract action as per the provision of law.

9. The Director of Public Health & Family Welfare, Hyderabad shall take action accordingly.
